Rental Agreement

Should the transponder be determined to not be in proper working condition, the driver will be notified and by signing below, the driver agrees to pay North Country Racing \$255.00 for replacement of the transponder. If a credit card was used for the security deposit, the driver agrees to have his credit card charged \$255.00. Failure to comply with this will disqualify the driver from entering any other ISOC sanctioned event and could cause a loss of membership.

I have signed it freely and voluntarily without any inducement, assurance or guarantee being made to me and intend my signature to be a complete assurance of compliance to this agreement to the greatest extent allowed by law.
